

# Terms and conditions of the "Refer an investor and you all win" promotion

The event is organised by BONDSTER Marketplace s.r.o., U Libeňského pivovaru 63/2, 181 00 Prague 8. The company is registered in the Commercial Register at the Municipal Court in Prague, file C227708.

# How does the recommendation work?

Recommend Bondster to your family or friends and ask them to enter your investor ID (your variable symbol) as a promo code when registering.

Once the Referred Investor who has entered your promo code has invested any amount within 90 days of the date of the User Account Agreement, you and the Referred Investor are entitled to a bonus of 1 % of the Referred Investor's invested assets during that period.

The bonus will be paid in 30-day increments in an amount equal to the increase in assets invested during the applicable 30-day period.

# **Model example**

The recommended investor invested a total of CZK 80,000 in Bondster within 90 days of the conclusion of the user account agreement, of which:

- The recommended investor had CZK 30,000 invested as of the 30th day after the conclusion of the user account agreement – you and the recommended investor are entitled to a bonus of CZK 300 (i.e. 1% of the invested assets as of the 30th day after the conclusion of the agreement).
- As of the 60th day from the date of conclusion of the user account agreement, the
  recommended investor held investments in the amount of CZK 80,000 (he/she has invested
  another CZK 50,000) you and the recommended investor are entitled to a bonus of CZK 500
  (i.e. 1% of the increase in assets held between the 30th and 60th day from the date of
  conclusion of the agreement).
- The recommended investor held investments of CZK 80,000 as of the 90th day from the date of
  conclusion of the contract (no new investments) neither you nor the recommended investor
  are entitled to any bonus during this period, as no new investments were made during this
  period (i.e. 1% of the increase in assets held between the 60th and 90th day from the
  conclusion of the contract is equal to zero).

Therefore, for a total period of 90 days from the date of conclusion of the user account agreement, you and the recommended investor will be entitled to a total of CZK 800 (CZK 300 + CZK 500 + CZK 0).



# Terms and conditions of the event

- Only new investors who have not yet had an account on Bondster can be recommended.
- The bonus is paid only on the basis of the amount of investments held or made, not on the basis of making a deposit into an investor account.
- The bonus is paid based on new investments made. If a Referred Investor makes only one investment of e.g. CZK 50,000 within a three-month period, both you and the Referred Investor will receive a total bonus of CZK 500 for the relevant 30-day sub-period in which the investment was made.
- Any repayment of principal (and similar transactions) within 90 days of entering into the User
  Account Agreement will reduce the amount of investments held. The model example does not
  allow for these types of transactions.
- The bonus is always paid into a virtual investor account held with Bondster.
- The bonus is always credited in the month following the month of eligibility. Example. The bonus entitlement will be credited by the fifth day of the following month, i.e. 5.7.2025.
